Waiver/Release Form

(One form needed for each member)

This release form must be read in its entirety & signed in full before being able to participate in any of the programs/clinics.

I, _____, the undersigned, do hereby forever waive Monadnock Happy Trails Association (MHTA), its members and its volunteers, responsible from any injury whatsoever incurred at any time at any MHTA sponsored trail ride, while riding my horse or any mount I choose, due to any cause whatsoever, and I hereby waive and fully release and hold harmless MHTA, its members and its volunteers, from any obligations whatsoever and know that all riding is done at my own risk. I also certify that I know that I am accepting and hereby accept full responsibility for the horse I ride and the horse's actions for the duration of time for which I ride said horse. If said owner is under the legal age, owner represents that parent and/or legal guardian have full knowledge of this release and waiver to MHTA, its members and its volunteers, and agree to waive and release.

I, _____, recognize the hazardous nature of horseback riding which is made unpredictable by both the nature of horses and by virtue of the fact that other riders and third persons may be negligent or unskilled in their use and control of other horses. In recognition of their unpredictability and other hazards, I hereby assume for myself (and/or on behalf of my child if I am signing for a minor), the risks associated with riding at any MHTA trail ride, and agree to hold MHTA, its members and its volunteers, harmless from any claims for personal injury, property damage, or death arising from or related to use and participation in riding. If said signee is under legal age, signee represents that parent and/or legal guardian have full knowledge of this release and waiver to MHTA, and fully agree to this waiver and release. I also understand that I must carry my own insurance. ANY MEDICAL EXPENSES INCURRED DUE TO ANY TYPE OF ACCIDENT AT AN MHTA TRAIL RIDE ARE THE RESPONSIBILITY OF THE UNDERSIGNED THROUGH THEIR OWN INSURANCE CARRIERS. ANY PROPERTY DAMAGE INCURRED BY RIDER AND/OR RIDER'S MOUNT IS THE RESPONSIBILITY OF THE RIDER. Under the Equine Activity Liability Act, each participant who engages in an equine activity expressly assumes the risks of engaging in and legal responsibility for injury, loss or damage to person or property resulting from the risks of equine activity.
